

#### **Holiday Safety and Crime Prevention Tips**

The Holidays are rapidly approaching and we love everything that comes with them. The lights, music, parties, large gatherings of family and friends or just cozying up next to a fire with hot chocolate and a movie with loved ones is something most of us look forward to all year. As amazing as all of that sounds, the holidays can also bring something else, Robbers!!! People fill their cars and homes with gifts for family and friends. With people out visiting more often, it gives robbers ample time to break into your home. Below are a few tips and tricks to lower your risk of being burglarized:

#### **General Holiday Safety and Crime Prevention Tips**

#### <u>At Home</u>

- Make sure all doors and windows have secondary locks (window pins, deadbolts, dowels, etc.) and use them!
- Don't hide spare keys in mailboxes or planters, or under doormats.
- Ensure that dark areas and entrances have outdoor lights that are turned on after dark.
- Keep trees and shrubbery trimmed so they do not conceal doors and windows. Remember, overgrown foliage can provide a hiding place for criminals.
- Place gifts where they can't be seen from the outside.
- Be sure to mail cards, checks or gift certificates from the Post Office or at a blue U.S. Postal Service collection box.
- Lock your vehicle and remove all the valuables. Yes, even in your driveway.

#### Strangers at your Door

- Use caution anytime there is a stranger at your door.
- Be suspicious of unexpected sales calls or deliveries. Ask for identification.
- Be aware of scams that criminals commit to take advantage of people's generosity during the holidays.
- Investigate charities before making donations. Ask how the funds will be used.

#### Leaving for the Holidays

- Ask a trusted friend, neighbor or Neighborhood Watch member to watch your home.
- Use timers for lights and radios while you're away.
- Remember to make arrangements for mail and newspapers.

#### Leaving for the Holidays continued:

- Don't advertise expensive toys, electronics, or other gifts received by the boxes left for garbage collections. Compress large boxes and place them in black garbage bags for pick-up.
- Add new items to your home inventory. Take photos or video of all items of value in your home and list each item's make, model, serial number and other information for insurance or police report purposes.
- Engrave new items to help identify them in the event they are stolen.

#### Avoid Porch Theft: 5 Tips to Protect Your Packages

- Network with Neighbors
- Have Packages Delivered to Work
- Leave Specific Drop-off Instructions
- Install Security Cameras

#### Tips to Avoid Package Theft

- Get a P.O. Box at Your Local Post Office
- Set Up Notifications to Track Your Packages
- Install a Security Camera
- Get Your Packages Delivered to Your Office
- Require a Signature on Delivery
- Reschedule Delivery or Ask for a Package Hold When on Vacation
- Insure Your Packages
- Ask Your Neighbors to Grab Your Packages

#### What to do if you've become a victim of a porch pirate

- Check with your delivery company to make sure your package was actually delivered.
- Know exactly what's in the missing box.
- If you see the thief, pay attention to what his or her vehicle looks like and its license plate number. Second to that get the thief's physical description – gender, approximate height and weight and what they're wearing – so you can tell an officer.
- Call 911 and ask for an officer to come to your home.
- If you have a security camera on your home, get a copy of the video to police. Ask your neighbors if their cameras captured the thief in action.

#### If you or anyone around you needs assistance during or after a burglary call 911 for emergencies or The Coosa County Sheriff's Office and we will dispatch a Deputy to assist.

## You Can't Make This Stuff Up

#### Prosecutors say a reckless driving suspect bit an NYPD officer's finger tip off

NEW YORK (AP) — A New York City police officer lost his left ring finger up to the first knuckle when a reckless driving suspect bit him.

28 year old Lenni Rodriguez Cruz, an illegal immigrant, could be sentenced to 25 years in prison for leading police on a wild car chase, crashing into several vehicles and biting a ser-



geant who was trying to put him in a holding cell.

The episode started shortly before midnight when a police officer patrolling in the Jamaica section of Queens spotted Rodriguez Cruz driving a car with license plates that weren't registered to the vehicle.

The officer tried to pull Rodriguez Cruz over, but he sped off, mounted a sidewalk and drove through a park, scattering parkgoers as they ran to safety.

Rodriguez Cruz kept driving and hit four vehicles including an unmarked police car that was part of a barricade set up to stop him. The driver of one of the cars that was hit was treated at a hospital for several injuries.

When officers finally pulled Rodriguez Cruz out of his crashed car, his breath smelled of alcohol, his speech was slurred and there was a cup containing an alcoholic beverage inside the car.

Officers took Rodriguez Cruz to the local police station, where he spit on the sergeant and bit the sergeant's finger tip off.

Rodriguez Cruz was arraigned on charges including assault on a police officer, driving under the influence of alcohol and driving without a license. *Article provided by AP News*

## NEIGHBORHOOD Safety Tips from Sheriff Michael Howell

# If you use a space heater for warmth, simple steps can help you stay safe

In the cold months, many people may need something extra to keep warm, whether that's because severe weather knocked out power or you just need some help to heat your home. A space heater may seem like just the fix, but experts warn that they can pose safety risks. On average, fires caused by portable heaters cause 65 deaths and 150 injuries a year. Here are six factors that fire experts say can make all the difference in keeping warm while staying safe with a space heater:

#### 1. Keep it at least 3 feet from anything flammable

The leading cause of space heaters igniting fires is placing them too close to flammable objects like a couch, curtains, or papers. It's also important to keep the space heater on a flat, stable surface.

#### 2. Don't leave it unattended

It only makes sense that you want the heat going as long as it's cold but with space heaters that's a big risk. When you can't pay attention to the space heater, you need to turn the heater off.

#### 3. Keep out of reach of children and pets

Just as you would not leave a candle within reach of children or curious pets, the same goes for space heaters. Keep your heater elevated where children or pets couldn't accidentally burn themselves or knock it over.

#### 4. Plug it directly into the outlet

Aside from contact with flammable objects, a big risk of fire is using surge protectors with a space heater. A surge protector may not be equipped to handle the power needed for the space heater so plug it directly into the wall.

#### 5. Make sure to have a working smoke and carbon monoxide alarm

Even if you're as careful as possible, sometimes things can still go wrong. The first line of defense maintaining working fire alarms. It is important to test fire alarms every month to make sure they are working.

#### 6. Look out for signs of malfunction

Fortunately, more modern space heaters often have safety functions that cause them to shut down when they aren't working properly but older models don't work that way. One big sign to look out for is the color of the flames on gas heaters. A blue flame is normal, but an orange flame means that it's not working properly and should be turned off immediately.

When was the last time you went fishing with a stick? No, I'm not talking about a spear that you might use to stab a fish, but a stick that you might use to catch one. When I was a kid, I loved to fish with a cane pole. The problem was that I didn't always have one, but I could always find a long stick. I would break off the limbs,

tie a line to the end of it, fasten a hook to the end of the line, put a <sup>Bro. Bill King Columnist</sup> worm on the hook, and catch myself a stringer full of bream. Last Sunday afternoon, I went fishing with such a stick. No, I had not returned to that mountain stream in Eastern Tennessee that I wrote about last week. The really strange thing was that I went fishing where there was no water, and I actually caught something. Instead of casting my line in water, I casually let it down over a backdrop with water painted on it. I didn't use a hook but a wooden clothes pin. I didn't catch a brim, or a bass, but a bunch of candy...one piece at a time. I was fishing at Lanier Baptist Church, where I am privileged to serves as pastor, during our fall festival.

We had a wonderful time. Inside, we had a cake walk and a book walk for everyone. Outside, we had games for the children. They pinned the face on a giant pumpkin painted on a sheet of plywood. They painted faces on real pumpkins as well. They pitched bean bags at boards with holes in one end, shot miniature basketballs at a little goal, and bowled with a plastic ball and pins. We played on a giant- inflatable slide and a bounce house, courtesy of East Liberty Baptist Association. Those two items were extremely popular with the kids. I even saw kids now in their sixth-and-seventh decades sliding! The big hit of the afternoon was an appearance by an eight-foot-tall robot named Ace Justice. He rode a motor-powered scooter around and interacted with the children, as well as to a few adults, with his AI digitized voice. We ate charcoal grilled hotdogs and award-winning homemade chili. We presented the top-three chili cookers certificates suitable for framing. We finished the event with a program by my friend and professional illusionists Bruce "Kid" Davie, from Arkansas. Then, as everyone made their ways to their cars to go home, they stopped to trunk-or-treat in the parking lot. We all went home almost sick from all that candy and the other goodies we had eaten.

Fall festivals used to be called harvest festivals. These go back as far as Old Testament days and early European days. In America, they date back to the days when we were mainly an agricultural society that depended on our crops for our sustenance and livelihood. At the end of the growing season, and after all the crops had been harvested, there were giant celebrations. Most of those farmers and families had prayed that God would grant a gracious crop, and then gave thanks to Him afterwards. These were often hosted by communities, schools, and churches. It was at one of those events, many years ago, where I first fished for candy and prizes with a stick in a pond that had no water! Even though most of us are no longer farmers, this is still a good season of the year to celebrate how God has provided our needs and blessed.

## <u> The Yellow Dot Program</u>

The "Yellow Dot" program is designed to assist Alabama citizens and first responders in the event of an automobile crash or other medical emergency involving the participant's vehicle. The program can help save lives during the critical "Golden Hour" by improving communication at a time when accident victims may be unable to communicate for themselves. Pick up a "Yellow Dot" folder here at the Sheriff's Office, have your photo taken and printed.

A "Yellow Dot" decal on the driver's side rear window of a vehicle alerts first responders to check in the glove compartment for the corresponding "Yellow Dot" folder. Having this information following a crash helps first responders positively identify the person, get in touch with family or emergency contacts and ensures that the person's current medications and pre-existing medical conditions are considered when treatment is administered for injuries.



### roiect Lifesaver

Project Lifesaver is a radio transmission system designed to assist law enforcement and rescue agencies in locating lost or missing persons who have been diagnosed with Alzheimer's, Autism, Dementia, or other disorders that may prohibit them from communicating personal information such as who they

are or where they live. Project lifesaver can help provide peace of mind to caregivers. However, it does not replace the need for supervised care.

The transmitter is a small circular radio device on a wristband, approximately the size of a wristwatch. The transmitters and wristbands are worn 24 hours a day, 7 days a week and are difficult to remove without the appropriate tools. If the participant becomes lost or missing, the Sheriff's Office and emergency response services have specialized tracking equipment to help isolate the location of the transmitter the participant is wearing. The search will start from the last known location of the participant and work outward until the transmission signal is obtained. The goal is to determine the location of the signal in a quick, timely manner, minimizing the risk of harm to the loved one.

CCSO is proud to participate, along with the other agencies in Alabama, in this very worthy and worthwhile program; Sheriff Howell says this is another way we will live up to out motto, "To Serve and Protect" and he is

A citizen's involvement program where citizens, in cooperation with their local law enforcement agency, directly participate in the detection and prevention of crime. These citizens keep well informed about their neighborhood and of any suspicious, criminal or dangerous activities
