SHERIFF WELCOMES 2ND NEW DEPUTY IN 2018

The Coosa County Sheriff's Office is now back to having a full force following the hiring of its newest deputy earlier this month.

On March 20, Deputy Blake Richardson was hired to join the team and began working. Having previous law enforcement experience and being APOSTC certified, or certified by the Alabama Peace Officers' Standards and Training Commission, there was no waiting period for Richardson to undergo training and receive certification before being added to the force.



Richardson said he has worked for a couple of law enforcement agencies in Alabama, as well as a couple in Georgia. His law enforcement career includes being a deputy, police officer, K-9 handler, and traffic homicide investigator.

He has a total of approximately 10 years in law enforcement experience, having taken a couple of years away from law enforcement to work in land management.

Richardson's interest in law enforcement began through a family friend who was a police officer. The family friend invited Richardson to ride along one day when he was still in high school, and Richardson said he enjoyed the experience. This then cultivated an interest in law enforcement.

A native of Georgia, where he attended high school in north Georgia, Richardson moved to Alabama to attend Auburn University.

At that time, he also began his law enforcement career at the Coosa County Sheriff's Office in 2005, where at the age of 18 he worked as a dispatcher.

"I missed it," Richardson said. "I started my law enforcement career here and came back. You feel more at home with a smaller agency."

Having moved around some over the past few years and working with other agencies, Richardson said he was ready to settle down and establish roots. He chose to return to Coosa County to do just that.

When asked what he missed about the Coosa County Sheriff's Office during his absence, he said, "I missed the camaraderie. The office is a family environment. Morale is up, and everyone enjoys coming to work. It makes things better."



It was also during his initial employment with the Sheriff's Office that he delved into being a K-9 handler. He got a dog that was approximately 1-and-a-half-years old in 2005.

Richardson said at that time he began training the dog to eventually work as a K-9 unit, and over the years he kept the canine certified. However, he said his canine companion just passed away two weeks ago.

Sheriff Terry Wilson described Richardson as "well-rounded" because of his variety of experience in different areas of law enforcement. Richardson has experience in narcotics, as well as some experience with in-depth criminal investigation.

Wilson also spoke of Richardson having "good patrol, narcotics and criminal investigation backgrounds."

"He has good experience to bring to the table and add to our team," Wilson said.

Richardson graduated from Auburn in 2011 with a degree in criminology. He recently

moved to the southeast end of Coosa County, residing in the Equality area, to better serve the people after taking the job with the Sheriff's Office.

He said his favorite thing about working with Coosa County again is "being part of a motivated and proactive Sheriff's Office that legitimately wants to deter crimes before they start and solve crimes to bring people closure."

Wilson said that Richardson has been going through local field and office training and riding with other deputies to familiarize him with the county and learn how things operate. He said Richardson has been "checking out everything" and is also on the schedule to visit the Neighborhood Watch groups to meet everyone.

He is pleased to have Richardson join the team and is excited about the experience he brings with him. He said that in a couple of weeks, Richardson will be out on his own to patrol and answer calls to service.

"I'm glad to hire another great guy to the team," Wilson said. "I look forward to getting him out there and seeing everyone."

No Easy Answers

The school shooting in Florida last month and the marches and demonstrations since have dominated the headlines. The airwaves are crowded with people demanding that something be done to stop this from occurring again. It is interesting to see how the battle lines are drawn. Of course, the anti-gun crowd and liberal media are quick to condemn the firearm involved as if it jumped up and started shooting by itself. Many of the folks involved seem to have the opinion that anyone who wants to protect their right to have a firearm is in effect endorsing this type of carnage. Obviously, that is ludicrous.

I am reminded of something my former neighbor once told when talking about someone jumping to an erroneous conclusion. He said a researcher

placed a grasshopper on a desk in front of him. The researcher clapped his hands and the grasshopper jumped. He removed one of the grasshopper's rear legs and again clapped his hands and the grasshopper again jumped although awkwardly off to one side. The researcher removed the other back leg and again clapped his hands. The grasshopper failed to move. The researcher recorded the results of his research writing, evidently when you remove both of a grasshopper's rear legs, it can no longer hear. I feel this is somewhat akin to what we are hearing following the school shooting in Florida. Are folks coming to the wrong conclusion when they blame a firearm for the school shooting?

Many have lauded the efforts of the school students who have come out demanding something be done. I have heard many people say we should listen to these children. While I think it is good they are expressing their views, their demands that the President immediately ban all firearms and that all legislators cut any ties to the NRA demonstrates their lack of understanding of the intricacies of the issue.

To call this a complex issue is probably an understatement. There are many valid viewpoints and some not so valid. I heard someone on television the other day mocking the NRA's contention that "Guns don't kill people, people kill people." I don't understand what they don't understand. I have yet to hear of a gun that went rogue and started shooting people on its' own. I feel we do not have a gun problem, we have a problem with some people having guns. I believe there are people who should not have access to firearms. However, it scares me to think about who will make those type decisions. I fear those people may be the same ones who think meat is made at the grocery store where no animals are harmed. I saw a news story talking about someone who had been apprehended outside the Whitehouse with an arsenal. The perpetrator had handgun AND a long gun! When I heard that I thought, please don't come to Alabama.

I believe it's not the guns, it's people who are bent on harming others. In the event a gun isn't available they will use a baseball bat, a knife, a vehicle or as someone is now doing in Austin, Texas, a




bomb. Stopping this type activity isn't going to take a ban on guns, knives or any other weapon, it is going to take a change of heart.

Yes, I believe we need to make our schools safer. We need more access to mental health care and we must develop better coordination between mental health professionals and law enforcement. We might want to explore ways to try to keep people from wanting to kill one another and we shouldn't put the picture of the killers on the screen every fifteen minutes. Maybe there should be consideration given to the breakdown of the family and the devastating effect that is having on our society.

Obviously, there is no quick fix or simple answer. However, the answer will only be found by folks working together. I find interesting that so many folks who demand tolerance of their viewpoint are totally intolerant of an opposing idea. I believe in this instance almost everyone wants the same outcome, getting there is the difficult part. Praying for our schools is a good start.

As I pen these words, the news is reporting a school shooting in Maryland. A male student apparently upset over a break up with a girl brought a handgun to school. He shot the girl and another male student. He was confronted by a school resource officer who shot and killed him. The news

Alexander City Man Arrested for Drug & Firearm Charges

An Alexander City man was arrested on drug and firearm-related charges following a traffic stop. On February 19, deputies on patrol on U.S. Highway 280 observed a vehicle traveling at a high rate of speed. They made a traffic stop, and as they approached the vehicle they could smell a strong odor of marijuana coming from it.

They noticed there were two people in the vehicle and had both get out. During the process of patting down the two individuals, deputies found a

large amount of cash and six debit cards on the driver. Deputies then also conducted a search of the vehicle. green leafy substance, as well as a pistol.

At that time, the driver, 33-year-old Ronnie Lee Russell of Alexander City, was arrested for first-degree possession of marijuana and possession of a firearm by a violent felon. Russell's bonds were set at a total of \$15,000, and he has since been released on bond to await trial.

His possession of marijuana charge was increased to first-degree because he had a prior marijuana charge. Therefore, this made his recent charge a felony.

Additionally, the passenger, Danny Curtis McNeal, had failure-to-appear warrants in another county. He was picked up and arrested by another agency.

Clanton Man Arrested For Theft by Deception

Man found to have made purchase using counterfeit bills

The Sheriff's Office arrested a man on a theft-related charge after he allegedly made a purchase using 25 counterfeit \$100 bills. On February 27, the Sheriff's Office received information from a victim in the Cottage Grove community. The victim said he had sold a vehicle to a white male subject for \$2,500.

The victim then informed investigator Capt. Scott Hammond that while he was purchasing an item, one of the bills he used was determined to be counterfeit. After meeting with the victim, he informed Hammond that a white male who was staying at the Days Inn in Alexander City had bought his vehicle.

Afterward, he had discovered that all \$2,500 in bills was counterfeit, with all bills having the same serial number. The investigation began with deputies going to the Alexander City Days Inn to locate the sold vehicle and the subject. They discovered that 30-year-old Terron Corey Mims of Clanton was the buyer of the vehicle. Further investigation then led to an interview with Mims. From that interview, it was determined that Mims did purchase the vehicle with \$2,500 in counterfeit bills. It was further determined that he had paid \$250 cash in real money for the \$2,500 in bills.

After the interview with Mims, the purchased vehicle was located and returned to the victim. Additionally, \$2,100 of the counterfeit money was also recovered at that time and turned over to Secret Service, with an additional \$300 later recovered.

Mims was arrested on February 27 and charged with first-degree theft by deception. His bond was set at \$10,000, and he has since been released on bond to await trial. Following Mims' interview and arrest, Secret Service was notified of the counterfeit money. They came to the Sheriff's Office to interview Mims.

They then took possession of \$2,100 in the fake bills and are working a federal case. However, if Secret Service does not proceed with pressing charges against Mims, then the Sheriff's Office could have additional charges pending against Mims for 25 counts of possession of a forged instrument.

13 Two Arrested, One Arrest Pending In Ray Burglary

Two men from Ray community and Jackson's Gap were arrested in connection with a January burglary case. On January 8, the Sheriff's Office took a report for burglary and theft from Midsouth Quarry in the Ray community of Coosa County. According to the report, thousands of dollars' worth of tools were taken from the quarry.

The investigation broke open when a call came in from a citizen with information he or she received about who may have been involved in the quarry break-in. Investigator Capt. Scott Hammond followed up with the information received and gained knowledge of some of the suspects involved.

After going to a suspect's residence in the Ray community, it was found that some tools laying in his front yard appeared to be tools that were reported stolen from the quarry. While a deputy was taking photos, the suspect came to the residence and was questioned about the tools in his yard.

After talking with him, it was determined that 21-year-old Johnathan Lance Mann of Ray community was involved in the break-in. During an interview with him, it was discovered that there were other suspects involved in the burglary, as well. After interviewing Mann, he informed deputies where they could find more of the stolen tools in Jackson's Gap. Mann was arrested on March 7 and charged with third-degree burglary and first-degree theft of property. His bond was set at a total of \$35,000, and as of press time he remained in custody at the Coosa County Jail in Rockford.

Following his arrest, further investigation led to two additional individuals being named as suspects. One of those was 23-year-old Dustin Lee Hardy of Jackson's Gap, where some more of the stolen tools were located. Hardy was arrested last Friday, March 9, for third-degree burglary and first-degree

theft of property. His total bond was set at \$35,000, and he has since been released on bond to await trial. After talking with witnesses and the other two suspects, it was further determined that 34-year-old Joshua Ryan Windsor of Alexander City was also involved in the burglary.

Windsor was interviewed while in custody in the Tallapoosa County Jail. Warrants have been obtained on him for third-degree burglary and first-degree theft of property, and a hold has been placed on him for Coosa County.


The majority of the stolen items have been recovered.

The Yellow Dot Program

The "Yellow Dot" program is designed to assist Alabama citizens and first responders in the event of an automobile crash or other medical emergency involving the participant's vehicle. The program can help save lives during the critical "Golden Hour" by improving communication at a time when accident victims may be unable to communicate for themselves. Pick up a "Yellow Dot" folder here at the Sheriff's Office, have your photo taken and printed.

A "Yellow Dot" decal on the driver's side rear window of a vehicle alerts first responders to check in the glove compartment for the corresponding "Yellow Dot" folder. Having this information following a crash helps first responders positively identify the person, get in touch with family or emergency contacts and ensures that the person's current medications and pre-existing medical conditions are considered when treatment is administered for injuries.



<u> Project Lifesaver</u>

Project Lifesaver is a radio transmission system designed to assist law enforcement and rescue agencies in locating lost or missing persons who have been diagnosed with Alzheimer's, Autism, Dementia, or other disorders that may prohibit them from communicating personal information such as who they are or where they live. Project lifesaver can help provide peace of mind to caregivers. However, it does not replace the need for supervised care.

The transmitter is a small circular radio device on a wristband, approximately the size of a wristwatch. The transmitters and wristbands are worn 24 hours a day, 7 days a week and are difficult to remove without the appropriate tools. If the participant becomes lost or missing, the Sheriff's Office and emergency response services have specialized tracking equipment to help isolate the location of the transmitter the participant is wearing. The search will start from the last known location of the participant and work outward until the transmission signal is obtained. The goal is to determine the location of the signal in a quick, timely manner, minimizing the risk of harm to the loved one.

CCSO is proud to participate, along with the other agencies in Alabama, in this very worthy and worthwhile program; Sheriff Wilson says this is another way we will live up to out motto, "To Serve and Protect" and he is extremely proud to offer this great service to Coosa County!

<u>Neighborhood Watch Program</u>

A citizen's involvement program where citizens, in cooperation with their local law enforcement agency, directly participate in the detection and prevention of crime. These citizens keep well informed about their neighborhood and of any suspicious, criminal or dangerous activities that may be occurring. Coosa County has five communities that participate with the CCSO in this program. Their meetings are scheduled every month, the dates and times are indicated.
