## Who Knew?

If you read this publication every month, you might possibly recall what I wrote in January. To jog your memory, the title was, "Another year, what will it bring?" I talked about the many innovations that have come to law enforcement and how things are ever changing. The next to last line read: What on earth will they come up with next? I don't know, but I'm sure something else is coming down the pike!

I do not claim to be a prophet, but oh my goodness, I would have never believed it if you had told me a pandemic would occur and it would drastically change the way we live our lives! When I said something else was coming down the pike, I sure had never imagined that. If you had told

me the bank in Rockford, and probably everywhere, would have a sign posted out front that said please wear your mask in the bank, I would not have believed you.

Later in the article I asked, "What will 2020 bring?" I never thought the answer to that question would be a call from many communities across the country to defund their police departments! While there have always been those who hated the police, I never thought I would actually see municipalities voting to defund their police departments. ## Stewartville Man & Woman Arrested for Animal Cruelty



A man and woman of the Stewartville community were arrested on animal cruelty charges following an investigation. Sheriff Michael Howell said that on September 6 a report was filed in reference to animal cruelty, specifically cruelty to dogs, at a residence on County Road 68.

Deputy Fenn began investigating the case and located the dogs in question. He took photos of the animals and proceeded to get them treatment. The investigation determined that it was indeed animal cruelty based on the condition of the dogs and what they had endured.

## Tallassee Man Arrested for Arson

A Tallassee man was arrested after allegedly setting fire to an our building near a residence. Sheriff Michael Howell reported that on October 20, the Sheriff's Office and firefighters received a call of service to County Road 53 in reference to someone setting fire to a building.

After arriving at the scene, they made contact with the victim, who was able to identify the suspect involved in the case. Upon investigating, deputies arrested 33-year-old Justin Lee Curtis of Tallassee on October 25 for setting fire to a building next to the victim's residence.

Curtis was arrested on the charge of second-degree arson. His bond was set at \$30,000, and as of press time he remained in custody at the Coosa County Jail awaiting trial.

That investigation culminated in the arrests of 28-year-old Taylor Dane Scott and 25-

year-old Herlinda Rachelle Hernandez, both of Stewartville, on the charge of aggravated cruelty to animals. Both were arrested on November 5, and the bond for each of them was set at \$5,000. They have since been released on bond to await trial.

## Sylacauga Woman Arrested for Forgery

A Sylacauga woman was arrested on forgery-related charges after making yard sale purchases. Mandy Kay Lucas Corbitt, 42 years old, had reportedly gone to a yard sale off of County Road 150 on two different occasions. Each time, she completed her purchases using counterfeit \$100 bills.

The Sheriff's Office investigated the case and determined that Corbitt had been in possession of the counterfeit bills. She was arrested on October 20 on two counts of possession of a forged instrument. Her bond was set at a total of \$10,000, and she has since been released on bond to await trial.

## **Equality Man Arrested on Stolen Property Charge**

An Equality man was arrested following a theft that occurred in Autauga County. Sheriff Michael Howell reported that the Sheriff's Office was contacted by an individual from Autauga County who believed their camper trailer had been stolen.

Further investigation led to discovering that the camper trailer had been stolen in Autauga County, and it was found in Coosa County. Eric Paul Robbins, 46 years old of Equality, was found to be in possession of the camper trailer.

He was arrested on November 9 and charged with first-degree receiving stolen property. His bond was set at \$20,000, and as of press time he remained in custody at the Coosa County Jail awaiting trial.

Howell reported that after locating the camper trailer, it was returned to the victim. Additionally, he explained that the victim and offender did not know each other.

## Two Men Arrested at Rehab Facility

Two men were arrested in separate incidences at a rehabilitation facility in Coosa County earlier this month. Sheriff Michael Howell reported that on November 9 the Sheriff's Office was dispatched to Farm Ministries in the Stewartville community. At that time, a search was conducted in reference to an individual at the facility, William Tyler Sorge.

During that search, deputies located some Suboxone. Sorge, 23 years old of Birmingham, was then arrested on the charge of possession of a controlled substance because he did not have a prescription for the Suboxone. Sorge's bond was set at \$5,000, and as of press time he William Tyler Sorge remained in custody at the Coosa County Jail awaiting trial.

Additionally, Howell said that on November 10 the Sheriff's Office was again dispatched to Farm Ministries, this time in reference to drug activity. At that time, the residents at the facility were searched. Deputies located some synthetic marijuana in a bag belonging to one of the individuals.

That search resulted in the arrest of 32-year-old Dabray Dantrell Rudolph of Greenville. He was also charged with possession of a controlled substance. Rudolph's bond was set at \$5,000, and he has since been released on bond to await trial.

Farm Ministries is a 12-step Christian program and rehab facility for males who are addicted to drugs or Rudolph alcohol or both. Its stated mission is "to help men who are addicted to drugs and/or alcohol recover and become productive in today's society. To help them and their families understand the disease of addiction and how to stay clean and sober one day at a time. By working a spiritual program, families and loved ones can be reunited."

## **High Speed Chase Leads to Arrest**

A routine patrol followed by a high speed chase ultimately led to the arrest of an Alexander City man on multiple charges. Sheriff Michael Howell said that Deputy Dawson was recently patrolling the U.S. Highway 280 and Alabama Highway 9 area when he observed a vehicle traveling in excess of 90 miles per hour.

Dawson attempted to stop the vehicle, but it continued along Highway 9 before exiting onto Highway 280. As the vehicle traveled toward Alexander City on Highway 280, it increased to PJ Whetstone speeds up to 120 miles per hour during the pursuit. Eventually, the vehicle stopped at Koons 3 off of Jefferson Street in Alexander City. The Alexander City Police Department assisted with the pursuit.



The chase culminated in the arrest of 30-year-old PJ Whetstone of Alexander City on November 15. He was charged with driving under the influence of alcohol, attempting to elude law enforcement, reckless endangerment, reckless driving, and second-degree criminal mischief.

His bond was set at a total of \$7,000, and as of press time he had been released on bond to await trial.

## 12 Please, With Everything Within You, Have A Merry

On the one hand, I can hardly believe fifty years have already passed since that night. On the other hand, it seems like that was in another lifetime. Thursday evening, December 10, 1970, is burned deeply in my memory. I have replayed it in my mind more times than I can count. I've wished I had said more. I've wished I had asked more. I had not seen my dad for almost two weeks. I'm thankful that I had a least one more night with him. That Thursday was the last time I would ever see him or speak to him again, at least in this world. We were both too young. He was only 54, and I was only 15. This week marks the 50<sup>th</sup> anniversary of his sudden passing.

The final two years of Dad's life were spent driving one of his trucks on long hauls. He was home for Thanksgiving but left right afterwards. He took a load of something to Mexico, or New Mexico, picked up another load there

and took it to California. Somewhere along the way he began to get sick with a cold. Rather than seeing a doctor there, he opted to drive back home. By the time he reached home, he was so sick he couldn't get out of his truck and walk in the house without assistance. He looked horrible and was burning up with fever. Mama tucked him in bed and did all the things that Mama's do. Soon, he called me to his bedside. He gave me a giant-wooden pencil with New Mexico written on it. I still have it. He was so weak and hoarse that his voice was almost gone. I leaned in close to hear what he said, but I've never forgotten our conversation. I've never known for certain, exactly what he meant when he said he wasn't going back out on the road again. The next morning he went to see his doctor, and he sent him directly to the hospital. A strep infection and fatigue had taken a toll on his system. He was a diabetic, and his sugar level had risen to over 500.

I went on to school on that Friday, and then spent that night with my friend David. Somewhere around 2:00 that night, I heard a phone ring. Even though I had not imagined he was going to die, when I heard the phone, I said to David, "I think my dad just died." In a few minutes, David's mom came in, sat beside me on the bed, and told me the bad news. We buried my father on a cold and snowy day, less than two-weeks before Christmas.



Christmas of 1970 was one of the hardest and saddest Christmases I've ever experienced. One week after Dad died, my Uncle Webster was killed in a car accident. Christmas should be a time of joy and happiness. It should be a time when families are together...when they laugh, sing, eat way too much, and exchange presents. Christmas should be all those things, but sometimes it simply isn't. For many, it is a season of sadness, depression, and a longing for those who've gone. I truly understand. I've never had a man-toman talk with my dad, but sometimes I want to so badly it hurts. If this is where you are this Christmas, I know the pain, and I'm praying for you. The wound eventually heals, but it does leave a scar. Please know that God loves you, and He cares about your pain. He gave up His Son for you and me. Please spend time with those you have left. Love them and let them love you. Even if all your family is gone, find a friend, find someone to be with. Please, with everything within you, have a merry Christmas!

## Programs Offered by... Coosa County Sheriff's Office

## **The Yellow Dot Program**

The "Yellow Dot" program is designed to assist Alabama citizens and first responders in the event of an automobile crash or other medical emergency involving the participant's vehicle. The program can help save lives during the critical "Golden Hour" by improving communication at a time when accident victims may be unable to communicate for themselves. Pick up a "Yellow Dot" folder here at the Sheriff's Office, have your photo taken and printed.

A "Yellow Dot" decal on the driver's side rear window of a vehicle alerts first responders to check in the glove compartment for the corresponding "Yellow Dot" folder. Having this information following a crash helps first responders positively identify the person, get in touch with family or emergency contacts and ensures that the person's current medications and pre-existing medical conditions are considered when treatment is administered for injuries.

## Project Lifesaver

Project Lifesaver is a radio transmission system designed to assist law enforcement and rescue agencies in locating lost or missing persons who have been diagnosed with Alzheimer's, Autism, Dementia, or other disorders that may prohibit them from communicating personal information such as who they are or where they live. Project lifesaver can help provide peace of mind to caregivers. However, it does not replace the need for supervised care.

The transmitter is a small circular radio device on a wristband, approximately the size of a wristwatch. The transmitters and wristbands are worn 24 hours a day, 7 days a week and are difficult to remove without the appropriate tools. If the participant becomes lost or missing, the Sheriff's Office and emergency response services have specialized tracking equipment to help isolate the location of the transmitter the participant is wearing. The search will start from the last known location of the participant and work outward until the transmission signal is obtained. The goal is to determine the location of the signal in a quick, timely manner, minimizing the risk of harm to the loved one.

CCSO is proud to participate, along with the other agencies in Alabama, in this very worthy and worthwhile program; Sheriff Howell says this is another way we will live up to out motto, "To Serve and Protect" and he is extremely proud to offer this great service to Coosa County!

## <u>Neighborhood Watch Program</u>

A citizen's involvement program where citizens, in cooperation with their local law enforcement agency, directly participate in the detection and prevention of crime. These citizens keep well informed about their neighborhood and of any suspicious, criminal or dangerous activities that may be occurring. Coosa County has five communities that participate with the CCSO in this program. Their meetings are scheduled every month, the dates and times are indicated.
