All to Jesus I surrender, Make me Savior, wholly Thine;


Let me feel Thy Holy Spirit, Truly know that Thou art mine.

#### New Deputies at the Sheriff's Office

As your Sheriff, I would like to take this opportunity to introduce and welcome two new members to the Coosa County Sheriff's Office.

Deputy Dalton Lucas was officially welcomed to the Sheriff's Office on September 24, 2019. Deputy Lucas spent a majority of his adolescents in Alexander City, Alabama. He attended and graduated from Horseshoe Bend.

After his graduation, he enlisted himself into the Army
National Guard. Throughout his 6 years in the guard,
Deputy Lucas served in a deployment to Afghanistan and Kuwait for one year. He has earned several awards throughout his military career, a couple of them being the Army Achievement Medal and the Army Accommodation Medal.

Before Deputy Lucas's deployment, he underwent Emergency Medical Technician (EMT) and Firefighter training through the Alexander City Fire Department. After his journey as an EMT and Firefighter, Deputy Lucas moved to Auburn, Alabama and managed to accumulate 3 years of combined experience as a Corrections Officer at both Lee County and Chambers County Jail.

After the Deputy's deployment, he immediately applied to the Alexander City Police Department (ACPD) and was sent through the Police Academy. After 13 weeks at Northeast Alabama Law Enforcement Academy, Deputy Lucas earned his certification and began his career as a patrol officer.

During his first year, he became SWAT certified through Alexander City Police Department, where he pursued frequent trainings and classes to advance his skill further. 

Deputy Travis R. Ward is a life long resident of Coosa County. Ward attended Weogufka Elementary School and graduated from Central High School Coosa County in 2010. Each state has its bail bond structure, which offers someone who has been charged with a crime the opportunity to get out of jail. When a person is bonded out, this allows a person to remain out of jail until they go to trial. Even though each state is different, the principles are the same. When a person is charged with a crime and, if someone is thinking about posting bail for someone, take time to consider what the law states. Over the next few months, we will inform you how the criminal procedure works as it pertains to the bail/bond process. We will start with the qualifications for bail/bond.

Both bail and bond are related to the same legal process. Bail is the security given to a court for release of an arrested person. A bail can be of different types, and can include cash, property, surety bond, etc. If the person is required to deposit the bail amount in cash, he/she has to pay the same in cash. A bond can be used to pay the bail. Though posting a bond means furnishing a surety bond, bail payment in cash or by pledging property is also referred to as bonds. Bail is granted on the basis of factors, like the seriousness of the offense, the criminal record of the arrested person, laws of the state and is set by judicial officers of all courts, not the Sheriff's Office.

#### Kinds of bail.

For persons arrested and taken into custody, there shall be four kinds of bail used in this state. No other form of bail may be approved and accepted by any judicial officer, court clerk, magistrate, or any other person designated to accept and approve bail as stipulated. The four kinds of bail shall be judicial public bail, cash bail, property bail, and professional surety bail. Their definitions are as follows:

- <u>CASH BAIL</u>. Cash bail is when the defendant or some person on behalf of the defendant deposits cash in an amount equal to a part or the total sum of the bail as set by the judicial officer to the clerk of the court having jurisdiction over the case. Acceptance of cash bail shall conform to Division 9.
- JUDICIAL PUBLIC BAIL. Judicial public bail is the release of any defendant without any condition of an undertaking relating to, or a deposit of, security. Such bail shall be granted to persons subjected to custodial arrest only by a judicial officer having jurisdiction over the defendant and in accordance with the procedures established in Division 7 of this article.
- **PROFESSIONAL SURETY BAIL**. Professional surety bail is when a defendant is released on bail by having a professional surety or professional bail company execute a bond on behalf of the defendant and becoming surety on the bail. Such companies shall meet the qualification requirements of Division 10.
- **PROPERTY BAIL.** Property bail is when a defendant is released on bail by having at least one or more property owners that own property in the State of Alabama, execute or become bail or surety for the defendant. Such property owners shall qualify and meet requirements applying to property bail as set out in Division 8.

#### Trick or Treat Safely

If I were to tell you someone was going to dress up in a disguise, come to your door and demand that you give them something, you would probably begin planning how you would defend against such an attack. Well something along those lines may very well happen at the end of October. It's not an attack, it's Halloween. Millions across the country will take part in the activity. While there is a lot to enjoy on Halloween, there are many dangers trick or treaters must be aware of. Many of these dangers are not anything a child, whose goal is to

receive as much candy as possible, will ever think about. That's why trick or treaters MUST be accompanied by a responsible adult.

There are many safety concerns that must be considered by those who decide to engage in trick or treating. Unfortunately, it is often necessary for trick or treaters to walk in or alongside the street. For this reason, costumes that are dark in color should be avoided. If a dark costume is utilized, it should have reflective panels or tape on it. Another great idea is for everyone to carry with them a flashlight or glow stick. Even a small light is highly visible in the dark. Children should not wear a mask that obstructs their vision or breathing or any commercial costume that is not labeled as flame resistant.

For safety sake it is best only to approach houses of people you know. Even then, an adult should accompany children to each door. Children should NEVER approach any house that is not well lit and does not have a porch or outside light on. Children should be cautioned that they should NOT enter any home or vehicle without permission from their parents.

A great alternative to going door to door in Coosa County is to attend a community event in your neighborhood. I know Rockford has an event each year and several churches host trunk or treat events. These events normally begin well before sundown and are normally well monitored.

No matter where children trick or treat, parents should inspect all treats and dispose of anything that seems to have been tampered with, has been opened, or is not wrapped. Working together we can have a safe and successful Halloween.

# Recent News

#### **Three Arrested For Burglary & Theft**

Thanks to an observant individual, three women from the Sylacauga area were arrested on burglary and theft charges, with two of them also being arrested on drugrelated charges.

Sheriff Michael Howell reported that on August 23, an individual called the Sheriff's Office and stated that they saw a suspicious vehicle pull behind a residence on County Road 150, which is in the Weogufka and Stewartville areas.

Sgt. Frankie Jones arrived at the scene and located the vehicle, along with some individuals. Howell reported that two individuals were coming out of the residence with some items at the time Jones arrived, and a third individual was entering the residence.

Reportedly the women also had some items taken from the house that were found in their vehicle. While making contact with the individuals, Jones also discovered methamphetamine and a glass pipe commonly used to smoke meth. All three individuals were arrested the same day.

Amber Northcutt, 32 years old, was charged with third-degree burglary, third-degree theft of property, possession of a controlled substance, and possession of drug paraphernalia. Her bond was set at a total of \$37,500 for those four charges.

Ashley Chaviers, 39 years old, was arrested on the charges of third-degree burglary, third-degree theft of property and possession of a controlled substance. Her bonds were set at a total of \$32,500.

Jessica Thompson, 25 years old, was charged with third-degree burglary and third-degree theft of property. Her bonds were set to total \$27,500.

All three women from the Sylacauga area had been released on bond to await trial.

#### Fourth Individual Arrested in Burglary Case

A fourth individual has now been arrested in connection to a burglary and theft case that occurred at a residence on County Road 150 near the Weogufka and Stewartville communities.

Three women from the Sylacauga area were arrested in reference to that case. On September 3, 50-year-old Todd Duffee of Sylacauga was arrested on the charges of third-degree burglary and third-degree theft.

Duffee's total bond was set at \$30,000. He remains in custody at the Coosa County Jail awaiting trial.

#### **Three Arrested on Drug Charges**

Three people from the Sylacauga and Stewartville areas were arrested last on drug-related charges during the process of following up on a warrant. On September 3, law enforcement officers were attempting to make an arrest of an individual for whom they had a warrant. While that individual was not located at the residence, officers found three other individuals at the residence.

Further investigation determined that all three individuals had methamphetamine in their possession. The investigation ultimately resulted in the arrests of 29-year-old Kaylyn Jones of the Stewartville

area, 33-year-old Chancy Temple of Sylacauga and 43-year-old Deena York of Sylacauga.

Each of the three was charged with possession of a controlled substance and possession of drug paraphernalia. Total bonds for each of the three were set at \$7,000.

All have been released on bond to wait trial.

#### Kellyton Man Arrested for Arson, other charges

A Kellyton man was arrested on five charges, including arson and burglary, after allegedly breaking into a home and attempting to start a fire. Sheriff Michael Howell reported that on August 15, the Sheriff's Office received a call from a female victim stating that someone had messed with their breaker box and was in the woods stalking her. The caller left the residence along Johnson Drive in the Kellyton area before law enforcement officers arrived.



Sgt. Frankie Jones and other deputies arrived on the scene and made entry Tyran Marbury into the residence. While they had been en route, another individual who lived at the residence had come home. That individual informed deputies that numerous items in the home were destroyed and that someone had attempted to start a fire in the house.

Kellyton Fire and Rescue arrived and, along with law enforcement, cleared the scene. They also discovered two places in the home where someone had reportedly attempted to start a fire.

The investigation ultimately culminated in the arrest of 50-year-old Tyran Marbury of Kellyton. He was arrested on August 21 on the charges of second-degree arson, third-degree burglary, second-degree domestic violence, and two counts of second-degree criminal mischief.

Marbury's bond was set at a total of \$60,000 for those five charges. As of press time he remained in custody at the Coosa County Jail awaiting trial.

Sheriff Howell explained that Marbury's girlfriend at the time shared the residence with other individuals. He also stated that Marbury had left the scene and was arrested later after turning himself in on August 18 for probation violation.

#### 14 Sylacauga man arrested during traffic stop

A routine traffic stop led to the arrest of a Sylacauga man on three felony charges. Sgt. Frankie Jones was on patrol on September 8 when he attempted to make a traffic stop. The driver reportedly threw two objects out of the window before stopping his vehicle.

After stopping soon after, the driver reportedly opened his door, and Jones spoke with him. Jones also located and investigated the two small bags that had been thrown from the vehicle. It was determined that the bags contained drugs. At that time the driver, 48-year-old Jeffrey McKinney of Sylacauga, was arrested.

McKinney was charged with possession of a controlled substance, ex-felon in possession of a firearm and possession of marijuana, which was elevated to a first-degree charge because of a prior conviction. His bonds were set at a total of \$12,500. He has since been released on bond to await trial.



#### Littering leads to additional charges

A case that began with trespassing and littering ultimately led to additional charges against a Deatsville man, including felony charges.

Sheriff Michael Howell reported that on August 30 he was following up on a complaint from a victim who had stated that someone kept going onto their property and throwing out trash. Upon arriving at the scene, Howell found a man identified as Jeffrey Robert Lee inside a vehicle at the residence.



Howell reported that Lee was trespassing on the property. Further investigation also Jeffrey Robert Lee determined that he had thrown out trash at the property and also that he had methamphetamine in his possession.

The investigation culminated in Lee, 34 years old of Deatsville, being arrested on the charges of possession of a controlled substance, possession of burglary tools, second-degree possession of marijuana, criminal littering, and third-degree criminal trespassing. Lee's bond was set at a total of \$18,000.

Later Sheriff Michael Howell reported that it was determined that Lee was a suspect in numerous burglaries that occurred on County Road 118 outside of Rockford. Howell explained that on September 17 they were able to arrest Lee in reference to three burglary cases from the County Road 118 area.

Lee was then charged with three counts of third-degree burglary, as well as one count each of first-degree theft of property, second-degree theft of property and third-degree theft of property.

He remained in custody at the Coosa County Jail awaiting trial.

#### Two Arrested for Manufacturing Meth

The process of serving a warrant resulted in the arrests of two individuals on charges of manufacturing methamphetamine after a meth lab was found in the home. Sheriff Michael Howell explained that the Sheriff's Office had a first-degree theft of property warrant for 39-year-old Jeremy Taylor of Weogufka. On September 4, deputies went to a residence on County Road 29 to serve the warrant.

Upon arriving at the scene deputies made contact with Elda Wooten, who informed them that Taylor was not there. However, Taylor was found inside the residence soon after that. Taylor was then arrested on his warrant, and Wooten, 51 years old of Rockford, was arrested on the charge of second-degree hindering prosecution. Deputies got a warrant to search the residence. They then found a meth lab in the house.

At that time, both Taylor and Wooten were also charged with manufacturing a controlled substance and possession of drug paraphernalia. Taylor's bonds were set at a total of \$30,000. Wooten's bonds were set at a total of \$16,000. Taylor has been released into the custody of a state agency. Wooten has been released on bond to await trial.

# Programs Offered by... Coosa County Sheriff's Office

## **The Yellow Dot Program**

The "Yellow Dot" program is designed to assist Alabama citizens and first responders in the event of an automobile crash or other medical emergency involving the participant's vehicle. The program can help save lives during the critical "Golden Hour" by improving communication at a time when accident victims may be unable to communicate for themselves. Pick up a "Yellow Dot" folder here at the Sheriff's Office, have your photo taken and printed.

A "Yellow Dot" decal on the driver's side rear window of a vehicle alerts first responders to check in the glove compartment for the corresponding "Yellow Dot" folder. Having this information following a crash helps first responders positively identify the person, get in touch with family or emergency contacts and ensures that the person's current medications and pre-existing medical conditions are considered when treatment is administered for injuries.

## Project Lifesaver

Project Lifesaver is a radio transmission system designed to assist law enforcement and rescue agencies in locating lost or missing persons who have been diagnosed with Alzheimer's, Autism, Dementia, or other disorders that may prohibit them from communicating personal information such as who they are or where they live. Project lifesaver can help provide peace of mind to caregivers. However, it does not replace the need for supervised care.

The transmitter is a small circular radio device on a wristband, approximately the size of a wristwatch. The transmitters and wristbands are worn 24 hours a day, 7 days a week and are difficult to remove without the appropriate tools. If the participant becomes lost or missing, the Sheriff's Office and emergency response services have specialized tracking equipment to help isolate the location of the transmitter the participant is wearing. The search will start from the last known location of the participant and work outward until the transmission signal is obtained. The goal is to determine the location of the signal in a quick, timely manner, minimizing the risk of harm to the loved one.

CCSO is proud to participate, along with the other agencies in Alabama, in this very worthy and worthwhile program; Sheriff Wilson says this is another way we will live up to out motto, "To Serve and Protect" and he is extremely proud to offer this great service to Coosa County!

## <u>Neighborhood Watch Program</u>

A citizen's involvement program where citizens, in cooperation with their local law enforcement agency, directly participate in the detection and prevention of crime. These citizens keep well informed about their neighborhood and of any suspicious, criminal or dangerous activities that may be occurring. Coosa County has five communities that participate with the CCSO in this program. Their meetings are scheduled every month, the dates and times are indicated.
